SQUADDING: Matches will be squadded. Please fill out and return the squadding sheet to: Harry A Baumann 9 North Fairview Avenue, Nanuet, New York 10954 845 639-5870. Squadding will be done on a first come first serve basis. If you are participating in another event, get your squadding sheet in early. Please indicate your 1st, 2nd, and 3rd choice for all matches. Squadding tickets will be distributed at registration. Team registration will be done before the first member of a team fires. Be sure to register your team for each event you participate in. There will be a \$4.00 NRA fee for each 1500 and a \$2.00 range fee for the Conventional Pistol, Service Weapon and Speed Challenge matches. There will be a special relay conducted on Monday June 14, 2010 for the designated range officers and for those who wish to compete in the rifle competition on Tuesday. Matches that will be conducted will be the conventional pistol, service weapon & Olympic Speed Challenge. The revolver & semi-automatic 1500 match will only be conducted on the match bulletin date, except a relay will be conducted at 8 AM each day for the range officers who will work that line for the day. .

ANY COMPETITOR WHO FAILS TO PICK UP SQUADDING PACKETS OR FAILS TO ARRIVE AT THE PROPER FIRING POINT WHEN THE RELAY IS CALLED, WILL LOSE THE OPPORTUNITY TO COMPETE IN THE EVENT.
